Guidelines for the income survey were discussed. The maximum mediam income could not be higher than 12,650.00. The survey forms are to be coded with parcel numbers and numbers, but no names. This would enable a cross check of survey forms if necessary by the F.H.A. We must have 75% of the water users complete a survey form. Director Noble and Sec. Hauck will begin work on this right away.

F.H.A. will get back to the board regarding any decision they make regarding help on deferred payments.

Hauck appeared before the Sierra County Board of Supervisors to inform them we would not have any liability coverage as of April 15, 1986, because our insurance carrier had refused to renew our policy. Sec. Hauck pointed out to the board that she had sent out 15 mailers to different insurance agents or agencies and had only received back The Board of Supervisors were to check on adding negative response. the ACWD to their policy. The Sec. to return to the next scheduled meeting of the Supervisors in two weeks. At their next meeting the Board of Supervisors expressed their concern but declined to add us to their coverage as they were also faced with the possible loss of their liability coverage. Since then the Insurance carrier that the District has always had has offered coverage but the rate would go from 1,800.00 The District had to decline the offer because the cost to 4,600.00. was prohibited even if passed along to the water users.
- Chairman Hauck asked for authorization to punchase signs for the district to post on their property. Director Noble moves to purchase all signs and necessary supplies to install these signs as needed. Director Simpson seconds. Ayes, unanimous.
- 3. Water Meters.— Report given on NFT leasing which has sent the paper work for a loan to the district to purchase and install water meters. The County has agreed to guarantee this loan and co-sign. FHA has requested that we use the money set aside for their loan payment to purchase the meters as the District has originally requested.

FHA would then re-write our loan when the Dec. payment was due. Director Niedjiedko moves to buy the water meters and notify NFT leasing that their funding will not be needed. Director Simpson seconds. Ayes, unanimous.

over 20,000 gallons.

Commercial or multiple family: 18.00 per month for the first 10,000 gallons
1.50 for each 748 gallons or fraction

thereof above 10,000 gallons.

Cemetery:

15.00 per month (same as residencial)

Fire Dept:

15.00 per month (same as residencial)

Dept. of Public Works:

50.00 per month flat rate (2 inch line)

Old Alleghany School Bldg:

30.00 per month flat rate (2 inch

Fire Hydrant Maintenance Fee: 6.00 per hydrant per month (remains the same)

The Alleghany County Water District has not had a rate increase for 6 years but has experienced a 100% increase in their operating expenses, (P.G.&E., insurance, and maintenance). We are not expecting to generate a lot of extra income with the installation of meters but with care and conservation of your water use our costs can be reduced.

The purpose of this meeting is to meet with Mr. Hart, F.H.A., regarding the re-amoratization of the Districts loan.

The District currently has two loans. The original amount of these loans were \$105,000 and \$4,000. The currect amount due is \$9,173.09 and \$265.00, due on Dec. 1, 1986.
