Status Report:

- 1. Problem with the generator at the pump house. The power was out in Alleghany for 28 hours. The generator was not on the proper setting to function properly so the chlorinator was off all that time.
- 2. The new compressor is working and survived the power outage and fluctuations with no problems.
- 3. Regarding the report from the State Health Dept on our annual inspection, all requirements of the inspection have been dealt with. A turbitity meter has been ordered. Hack is due out to do a service on all their equipment. The meter will be approximately \$900.00. Memcor has been contacted and they will be setting up a time to come out and service their equipment.
- 4. The State Health Dept from Redding called because he had heard a rumor that Alleghany was boiling their water. The Chairman assured him that that was not a fact. Possibly happening in Sierra City or that part of the county.
- 5. The Chairman again reminded the Board that we will need to find someone to attend classes for a license for a Water Treatment Operator. The Chairman's license expires on January 2007 and he will not be renewing it.

Church Report: It was reported that the Check from Sierra County for the Library Contract has not been received. Director Arbogast will check with the supervisor.

Camptonville Water Dept. has a Licensed Water Treatment Operator who is paid \$15.00 per hour to oversee a person who is paid \$10.00 per hour to do the grunt work. NID in Nevada County pays an Interim D1 License holder 30,000 per year but they must acquire an Interim D2 License within two years and then they are paid \$47,000 per year. The District will put together a letter to the community and schedule a town hall

meeting on March 11th at 3:00pm at the Firehouse to bring to the town the information needed.

Status Report:

- 1. The Chairman has opened a discussion of the problems facing the district when he was gone on vacation. Our pumps failed, the town was out of water and the storage tank was empty. A State of Emergency was called and the surrounding Fire Dept.'s were contacted and notified of the emergency situation and to the fact that we had no water to fight a fire. There was a problem with Sierra County and the office of OES and Tim Beals at the Dept of Public Works. Peters Well and Drilling was called and responded to Alleghany to check out the pumps. The old pumps could not be repaired so new ones would have to be ordered. There was a few days delay in receiving the new pumps and then Peters Well and Drilling came to Alleghany to replace the old pumps. The new pumps are working well. The tank is again full. Because of all the problems the Turbidity meter was not recording in range. That problem was also fixed. The new pumps were estimated to cost \$1300.00 each plus labor.
- 2. There was a discussion on costs for the District that are coming up before the end of the fiscal year. There will be a semi-annual payment to FHA due on June 2,06 and we are required to submit a special water test and the cost at this time is unknown.
- 3. The Chairman will start to hold training sessions for the Board Members at the pump house. The first one will be on May 24th at 9:00am.

Church Report: Secretary reports that the check for the Library rental is finally in the mail.

Public Response: None

New Business:

- Resignation from the Board of Directors has been received by Director Chandler to be effective immediately. Motion made by Director Arbogast to accept the letter of resignation with regret. Director Vierra seconds. Ayes, unanimous.
- 2. A brief discussion was held on the possibility and need to raise water rates to cover any compensation that will have to be paid to make the Water Treatment Operator a paid position. Regardless of how the Board goes with a new treatment operator they will have to be paid for their work. Up to this point the Chairman has done the job without being paid.
- 3. Director Downey discusses his upcoming schedule with the Board for this summer and for school that he is attending. The Board hopes that Director Downey can continue to serve as a Director and that the Board can work around his temporary work and school schedule.
- 4. Director Vierra asks about changing the meeting time from 7:30pm to 6:30pm. She was under the impression that we used to hold our meetings at that time. It was pointed out that perhaps the Fire Dept had but that the ACWD has always held their meetings at 7:30. The other Board members would prefer to keep the hours the same as they have been.
- 5. The Chairman has checked with the State of CA Health Dept to find out about regulations for horizontal drilling. Would we still need a treatment operator if we did this at the Ram Spring? They have said yes, we would. Mike Miller would propose to drill the test holes with small core drills and then have a certified drilling company come in to finish the job.

3. The Insurance policy for the FY 2006-07 has been renewed. The Secretary has asked the insurance company to provide a breakdown of the premium so that we know how much of the premium has to be paid by the church fund for

their portion.

The Preliminary budget is presented to the Board for discussion. The recent 4. major repairs and replacement of the 2 pumps has depleted our reserve fund. The budget for next year is cut to the bare bones and we are still short. We still are not receiving our tax money from Sierra County. Starting next year we will have to pay out some money to a Certified Water Treatment Operator. The cost is unknown at this point but the Board is aware that we will not be able to escape this cost. Discussion was held on all categories of the Budget. It was decided that there was no choice but to raise the rates for water service \$5.00 per service. The Cemetery will not have an increase because that billing is an annual \$100.00 and water is not used, the connection is there to provide fire safety during the summer months and turned off in the winter. The Preliminary Budget is tabled until the next meeting to be held on August 1st, 2006. Discussion is held on holding a public hearing to discuss the rate increase. A motion is made by Director Arbogast to send a letter to all members of the community, and post a notice at the Post Office about the scheduled Public Hearing to be held at the next meeting of the Board of Directors on August 1st, to discuss and pass a rate increase to take effect August 1st and be reflected in the water billings on September 1st, 2006. The motion is seconded by Director Vieirra. Ayes, unanimous

I would-like to make an opening statement as Chairman of the Board to the audience. I am aware that there are a lot of innuendos, statements, and questions that are circulating around the community regarding this upcoming election. First let me say that the Board is aware of the rumors and statements being made about the cost of this election. It has been reported that Ernest Finney is responsible for the cost of the election to our community. Let me state to you all that that is not the case. Even though there has not been an election for our board in 30 years it is mainly because no-one has stepped up and wished to serve on the board and go through the process of running for a board seat. It has been our experience that whenever there is a vacancy we have to go out and ask residents if they would be interested in serving. An election is the democratic process and a right to all that may want to run for an office. It is a fact that there will be a cost to the district of approximately \$1,000 dollars to cover this

election. But that has to be considered the cost of us doing our job and serving the community.

That said I would like to move on to some of the issues pertaining to the district that have been sent out to registered voters in Alleghany. I am going to read the correspondence that has gone around and then open the floor for discussion.

Read Mr. Finney's letter to voters dated October 16
Read Rae Bell's response dated October 18
Read Mr. Finney's letter requesting information dated October 18
Read Rae Bells response dated October

Your board would like to set the record straight.

Regarding the Water Treatment Operator License Exam: first let me make a statement regarding the facts of my license. That license is set to expire on January 1, 2007. Ever since a license has been a requirement of the State of Ca Health Dept. I have held a license and performed the duties of a Water Treatment Operator on a volunteer basic. When I made the decision to not renew my license 3 years ago, I informed the Board that we would need someone to step up and take the test and volunteer for the community. In all other water districts this is a paid position ranging from anywhere from \$20.00 per hour to \$47,000 annually.

Obviously this is a cost we cannot afford. There was a time when we thought we could contract with another treatment operator that was serving the small mountain communities in Sierra County and Nevada County to share those duties. As it has turned out all operators that we have contacted have said that they also will not be renewing their licenses. After 2 years of putting out the word about what we would need, 2 residents of Alleghany stepped forward and volunteered to study for and take the exam. This has just happened on Saturday, Oct 21. We wish to thank Bruce Coons and Burns Tenney for their effort and commitment to this District. However, let it be clear that at this time the job of Water Treatment Operator is still a volunteer position. We recognize the need for a paid position but the funds are not available as yet. The Board has scheduled town meetings on this subject but has received very little feed back or support for this problem.

My position is very clear. All I am doing is not renewing my license. I have not said I would be resigning from the board. That is a decision for the voters to make.

Per your request enclosed are copies of the Alleghany County Water District's last two budgets adopted by the Board of Directors.

Some notes regarding these budgets:

- 1. The church expenses are shown but covered with the annual Library Rental Agreement between the Sierra County Board of Supervisors and ACWD. In no way does any water revenue cover any church expenses. The community has held fund raisers and there have been personal contributions made by residents of this town.
- 2. The budgets show all areas of revenue for the District plus actual expenses paid out the previous year.
- 3. The increase of salary expense for the Fiscal Year 2006/07 was made to cover the expected rise in cost for Water Treatment Operator expenses after January 1, 2007. We had no idea what those costs would amount to at the time the budget was adopted but felt that an allocation was needed.

There are no audits or financial statements as the ACWD is on a 5 year plan with Sierra County. We are in plan year 3. You have received copies of the latest audits we have. In two years the District will have a 5 year audit done. This decision was made because of the cost of an annual audit (\$1,200 to \$1,600 per year). This plan was made with the approval of the Sierra County Board of Supervisors and Sierra County Auditor Van Maddox.

Mr. Finney's letter makes it sound like Alleghany's fixed personnel expenses for keeping our Water District running are higher than Downieville's.

I spoke to Len Kinzler who handles the water billing and bookkeeping for Downieville's Utility District yesterday. According to him Downieville's monthly overhead for the water system includes the following:

\$380 per month for his services that are the same as the services Donna Hauck currently provides to Alleghany for \$300 per month with the exception of the fact that he reads the meters and Donna does not.

ADDITIONALLY Downieville pays a plant operator who maintains the plant (Mark Dagle) \$500 per month and a licensed water operator (Dick Melim) \$400 per month for a total of \$1,280 per month. They also pay an additional \$25 per hour for repairs by other individuals.

In Alleghany we pay Donna \$300 per month to handle billing, accounting and collections plus \$100 per month rent for office space which includes phone and utilities. We also pay \$50 per month for a meter reader (Bob Hale) for a total of \$450 per month. Additionally if repairs and other help are needed Alleghany pays \$10 per hour. Our licensed water operator and maintenance man (Joe Hauck) does not get paid. Joe does bill mileage at the Federal mandated rate for trips to town for parts and repairs.

Fixed personnel expenses are \$930 less per month for Alleghany than they are for Downieville. (Or \$830 less if you include the office rent)

What Mr. Finney may not realize is that treatment, testing and compliance requirements are the same regardless of size. For example water-sampling expenses should be the same for Alleghany and Downieville as these requirements are set by the State. Audit expenses are also the same for both districts as well as compliance paperwork.

A public hearing is called anytime rates are raised. Whose voice is not being heard?

All ACWD meetings are public and are posted in advance yet Mr. Finney does not attend. The reason there has not been an election in 20 years is because this is the first time there have been more candidates than seats. It cost the water district \$1,000 because Mr. Finney chose to run in the election. This is the fee that Sierra County charges for us to have a ballot item. (NOT IN THE BUDGET)

A helping hand is always needed in a community like ours. I suggest Mr. Finney attend the Water Board Meetings on a regular basis so he knows what goes on. There are no secrets. If anything we can count on our fixed expenses increasing when Joe Hauck retires.

Dear Mike:

My name--Ernest Finney--is on your November ballot as a candidate for one of the three open positions on the Alleghany County Water District board. This will be the first election for seats on the ACWD board directors in some twenty years: until now, water board directors have been appointed, either by the ACWD board or by the county board of supervisors. This year, it will be up to the voters to decide.

I'm running for this position because I'm concerned about keeping the cost of water service reasonable and affordable for all of us in Alleghany. Now that the California Dept. of Health Services requires water districts to use licensed water treatment operators and distribution operators, this means additional operating expenses. I think it's time for us to consider if we might be able to reduce ACWD administrative expenses in other areas, perhaps by looking at how other county water districts handle expenditures.

It costs Downieville Water District, for instance, \$400 per month to handle accounting, billing, collection and reports for 225 water users. It costs ACWD over \$700 per month to handle accounting, billing, collection and reports for 53 water users. Could this be done for less?

I cannot promise lower water bills if I'm elected, but I can promise that your voice will be heard the next time an increase is discussed by the board.

I've owned my home in Alleghany at 102 Plaza for over 40 years. Although my work has kept me traveling a lot, I'm moving back now, and as a full time resident I'd like to represent you on the Alleghany County Water District board. I'd be glad to talk with you about your concerns--just stop by our house or give me a call at 287-3441 or catch me on the street--I'm the guy on the bike most mornings around 8.

I hope you'll consider giving me your vote.
