### A RESOLUTION TO ACCEPT THE BID FROM BRCO CONSTRUCTION INC FOR REPLACEMENT OF ALLEGHANY'S WATER STORAGE TANK

- 1. Alleghany County Water District applied to the Safe Drinking Water Fund DWSRF for funding to replace its water storage tank, project No. 4600012-006C ("The Project") and was approved for funding per Funding Agreement No. D17-02013 fully executed on July 20, 2017.
- 2. A request for bids for The Project was duly published and advertised beginning August 7, 2017 with a pre-bid meeting held on August 15, 2017 and a formal bid opening held on September 19, 2017.
- **3.** Completion of The Project requires hiring a contractor to perform the duties specified in the request for bids for replacement of Alleghany's water storage tank.
