The class will be held in Alleghany for 2 days. We will be notified when the manufacturer of the equipment is ready for the class.

Status Report:

1. The system is almost finished. A Transformer and relay are all that are left. When the system is finished the Board will be taken on a tour. Discussion on having a publicity day where the community can also tour the new plant. Discussion held on the chlorinator and the chemicals that will be necessary to purchase.

Public Response Time: Michael Miller approaches the Board for adjustment to his December, 1994 water bill. Mr. Miller feels that an adjustment should be made to the overage charges since the water leak could not be detected because of severe weather conditions. His feeling is that the Board should take into consideration that he did nothing to intentionly abuse water use and immediately corrected problem when it was found. The Board decided to table any decision till the next meeting. Mr. Miller agreed to pay the regular amounts due in a timely manner while wailing for a decision.

- 1. The district's engineer, Keith Sauers, was present and gave a background on why Alleghany had a new system installed. He also explained how the system functions.
- 2. Keith presented an amended permit application to State of California for the operation of the water system. Director Street moves to have Keith Sauers submit the permit application to the State of California to operate the system. Director Porter seconds. Ayes, unanimous.
- 3. Discussion held on the Memcor Service Contract Agreement. Keith explains the provisions in the contract to the board. Director Porter moves to purchase the service agreement from Memcor. Director Street seconds. Ayes, unanimous.

4. Discussion on the surplus sale. Bids to be opened at this meeting. I bid received by Cathy Matthews for \$355.00. Director Porter moves to sell the Honda Generator to Cathy Matthews for \$355.00. The money must be received by March 1st. Director Street seconds. Ayes, Porter, Street. Abstain, Hauck.

Water Test - Water test results for March 1995 - absent. Treasury Report: Park, Maintenance, and General Fund = \$20,972.79

Status Report:

- 1. Keith Sauers presented the board with a bill from the contractor of the system upgrade, M.C. McCollum. Keith has proposed that the district pay \$1,000 of the amount billed of \$1,562.50. The contractor has agreed to accept that amount as balance paid in full. Director Lucchesi moves to pay the contractor \$1,000 as amount owed in full. Director Street seconds. Ayes, unanimous.
- 2. Keith Sauers feels that there is still 3 problems with the system. 1) the auxiliary generator was shutting down prematurely. The problem has been solved and the generator is running correctly. 2) the water quality is censored and supposed to record automatically. Now it is not recording automatically but the sensor is working. 3) the controls on the equipment are not producing correctly. The manufacturer will send up a rep to fix it. He will coordinate that with the chairman, Joe Hauck.
- 3. There is a problem with the existing telemetry system. The wires are old and need to be replaced. Keith will search for solutions and possible sources of funding.


Public Response Time: None

Mr. Miller requested that the board allow him to pay the actual costs of pumping the water instead of the metered rate for the water. The cost of the bill for his water leak was 436.00. The actual cost of pumping that same amount of water was \$205.00. Discussion held. Director Lucchesi moves for the water district to change the system of billing on a case by case basis for any emergency

during the winter months that may cause a large water bill. Customers will be billed on a cost to pump water basis & not water used. Director Street seconds. Ayes, unanimous.

Hazel Lucchesi received a message of a family emergency and had to leave immediately. There being no quorum present the meeting was adjourned at 8:00 till next month.

They can continue to work as they have under the license of Keith Sauers. There are some switching problems that have not been worked out yet but Chairman Hauck is working on it.
- 3. The filters have been cleaned about 5 times since the system went on line. Chairman Hauck is happy with the way the system works. The filters are showing lots of impurities in the water pumped. The filters are doing their job by catching everything that shouldn't be in the water.





- 1. There are problems at the pumphouse. Chairman Hauck met with Keith Sauers, District Engineer, and the representative from Memcor. They were working on the problems all day on August 14th.
- 2. The water tank is low and reads like there is a leak in the system but we cannot find any outward signs of a break in the line. The Chairman and Faris will continue to monitor the situation.
- 3. The Ram Spring has been brushed and is re-growing rapidly. The park has been sprayed with roundup.
- 4. Mike Miller has requested we have the water service up and running at the school bldg. The valve is frozen and needs to be replaced. Discussion held on the request. Director Standley moves to fix the valve and have the service restored. Director Porter seconds. Ayes, unanimous.
- 5. Faris Dolgoff will re-instate his bond for his contractors license and will fix the Ram Spring collection area where the springs have broken out. FEMA will pay up to approximately \$2,500 to have the work done.

1. Discussion held on new budget for fiscal year 1995/96. All categories and possible expenditures were discussed. During the coarse of the budget discussion the District's secretary submitted a letter requesting consideration of a raise. The secretary has been making the same salary since 1982. She has suggested that the board either consider a \$100.00 month raise or consider paying an office space lease of \$100.00 per month. Also provided with the office space are utilities (PG&E, phone and fax) services. The office

lease will be the most economical to the district as they will not have to pay any employee taxes on the amount. A discussion was held. Director Street moved to pay an office lease of \$100.00 per month. The amount is to be retroactive back to the start of the new fiscal year. Director Porter seconded. Ayes, Street, Porter, Standley. Abstain, Hauck. Director Standley moves to approve a budget for the upcoming fiscal year of 1995/96 in the amount of \$25,825.00. Director Street seconds. Ayes, unanimous. A copy of the new budget is attached to these minutes.

Director Standley has submitted his resignation from the board to be effective after this meeting as he will be moving to Pike and will be considered out of the area to serve on the board. Director Street moves to accept with regret Tim's resignation. Director Porter seconded. Ayes, unanimous. The Chairman of the Board thanks Tim for all his time and service.

- 3. OES funds have been received. The district needs to send a change order to OES. The method of repair has changed from gunnite ditch to putting in coffer dams. The check has not been cashed as yet because the district needs to contact OES about the changes and if we find that the requirements are to complex we will return the check and not proceed under the regulations of the OES.
- 4. The Ram Spring pump house is running well with no problems at this time.
- 5. The cost to prepare the water and shutoff valve boxes for the new overlay in town to date is \$700.00. There will be more costs incurred before the project is finished.

Public Response Time: Dave Emery approached the board regarding his new water service. His property has been involved in a lawsuit and he has lost

his right to the property. It will revert to open land within the townsite. He has paid a portion of the agreed amount for the new service but would like the board to consider waiving the remaining balance due as he no longer owns the property. Director Luchessi moves to waive the remaining fee due but with the understanding that the outstanding water bill will be paid current. Director Street seconds. Ayes, unanimous.

Unfinished Business: None

New Business:

Director Luchessi has submitted her resignation from the board of directors to become effective November 19, 1995. The resignation is tendered because she will be moving to Downieville and will no longer fulfill the residency requirement to serve on the board. Director Street moves to accept with regret Director Luchessi's resignation and conveys the board's thanks for her years of service she has given the ACWD. Director Hauck seconds. Ayes, unanimous.
