Status Report:

Pump #2 went out over the Xmas holiday. A-1 Pump Service has been up to replace it. The District has not recieved a bill as yet but the estimated cost is around \$600.00 plus an installation charge. Pump #2 is the pump wired to the generator.

Page 2, (Minutes Cont'd) January 8, 1991

Director Standley discusses possibilities of wiring the other pump to the generator. The control lines to the telemetry system froze during the big freeze. They are O.K. at this time. The Cumberland Tunnel has been brushed by John Luchessi. Also 1/2 side of the park play court has had concrete laid to prevent the ground from sloughing off. The balance will be completed in the spring when the weather has warmed up.

The lessee at the 16 to 1 Mine (Royal Gold) called last month requesting more water. They were informed that we were not pumping at that time so he was receiving all the water that was available. They expressed their concern about the water flow saying that they were having a hard time running their mill as they did not have an adequate water supply.

The seat for the park swing has arrived. The company that it was ordered from sent the wrong parts for installation so they have been returned and the District is waiting for the correct ones to arrive so the installation can proceed.

Old Business:

The County of Sierra had placed an advertisement in the Mountain Messenger for the vacancy on the Board of Directors of the ACWD. Two people applied for the position, Debbie Nelson and Janice Street. The Board of Supervisors appointed Janice Street to fill the vacancy of Carol Butler. There was some discussion as to why the appointment was made by the Supervisors rather than by the Board of Directors of the ACWD. The reason was because this was a position that was up for election last November and the Director holding the position at that time did not apply for reappointment. Also no one took out papers to run for the seat. This then became the responsibility of the Clerk Recorder to see that the posiition was filled because of regulations in the election code. Sierra County has yet to notify the Board of Directors of the appointment so the District Secretary contacted Supervisor Lewis who informed her of the appointment and directed the District to swear Janice in at our next meeting.

The Secretary administered the oath of office to Janice Street.

There were two tenent billing forms submitted to the Board for approval. Director Wilkerson moves to approve the tenent billing form for Giles/Mirambet and McIntosh/Lilly. Director Standley seconds. Ayes, unanimous.

They are going to re-classify our water as a surface water source instead of the present classification as an underground water source. This will change some of our reporting requirements to the state. The director is to contact the district engineer, Kieth Sauers.

The Secretary was directed to contact the Health Dept. and notify them of our proper name and ask for a corrected billing. The Sierra County Auditor's office has sent a notice to the ACWD regarding a new charge to Special Districts for the cost of collecting their tax monies. The State Legislature has authorized Counties to pass along all cost of collecting tax monies to the districts that the tax money goes to. The bill to ACWD for Property Tax Administration Fee is \$1,213.14. A discussion was held and all Board members were in agreement that this is a fee that should be protested and not paid. The Secretary is to contact Mr. Hemphill about this.

Status Report:

Lowell Hiscox will shock the water tank with cholorine in the next few weeks. This procedure is a part of our regular maintenance that is performed every year at the beginning of summer.

The septic tank at the park restroom was full and needed to be pumped out. The Chairman called for estimates and had Roto Rooter of Yuba-Sutter & Colusa Co's come up to Alleghany for the job. Discussion was held on the problem of water seepage to the septic tank. Several suggestions were discussed but no dicisions were made. It was felt that the tank may be in the area were the natural springs drain from the hillside. This is causing an unusually large amount of water to seep into the cement tank. The tank will have to be sealed to correct the problem,

The lock hasp on the door to the restroom was broken again. This is the third time this has happened. It was suggested that a sign, similair to the one on the pumphouse door, be posted to try to cut back on vandaalism.

The rest of the system is functioning well.

Old Business:

The vacancy on the board is to be filled by Hazel Lucchesi. Hazel was present at this meeting to be sworn in as a Director of the Alleghany County Water District. The Secretary has Hazel read the Oath of Office. Hazel Lucchesi is now a Director.

A letter of resignation from Director Wilkerson has been recieved by the Board. A discussion stating the Board's regrets follows. Director Lucchesi moves to accept with regret the letter of resignation from Rebecca Wilkerson. Director Standley seconds. Ayes, unanimous. The Secreatry is directing to post for a vacancy.

Presentation made to the Board by the Secretary regarding software purchase for utility water billing. Four companies were contacted and asked to send demo disks and supporting documents. The Secretary went through the programs and presented the one she felt would best meet the needs of the District. A discussion followed. The Secretary reminded the Board that an allocation in this years budget was made for the purchase of the software and the fiscal year would be coming to an end soon. Director Standley requested that that feature be necessary if we purchase from Quest Data Systems. Director Street moves to purchase from Quest Data Systems, 1 software package for utility water billing. The cost to be \$1595.00. The software to have comparison totals for this month and this month last year for water consumption. Director Standley seconds. Ayes, unanimous.

There was a report on landscaping at the park and the possibility that Mr. Helm form Pike would be able to help. Mr. Helm has started a new job at Chico State and he has said that the students in his ag classes could make this a field project. He will be contacting the Secretary in September when school starts.

The park is in need of having the barricade for autos finished. A discussion was held on the different methods that could be installed. The Chairman is to check with Tim Beals of

Sierra County DPW to see if there is any surplus guard rail left like the one installed at Plum Valley.

All water districts were asked to show their support in complaining to our state legislators about the bill that they passed which would impose new water fees on all districts. The Secretary is to send letters to all water customers asking them to send letters of protest to our state legislators. A sample letter will be sent to the customers for their use.

There was a report made to the board about a meeting between the Secretary of the district and the County Auditor, Don Hemphill. The purpose of the meeting was to discuss tax revenue to the district. The auditor reported that because of a decrease in mining activity at the 16 to 1 mine our tax revenue would be cut in half this year.
